User's Terms and conditions of "Al-Thaqeel" application

These terms and conditions represent a formal agreement "a contract" between Al-Thaqeel App. and the customers using Al-Thaqeel App, which is an electronic platform that allows the process of renting heavy equipment by linking the lessor with the lessee by providing the opportunity to the lessor to offer his commodity "heavy equipment" on the platform and providing the lessee with an opportunity to chooses the desired equipment and then, the lessor delivers it with its driver to the locations predetermined by the lessee.

- service provider, knowing that Al-Thaqeel will not remove the ban on the customer until the due service fees are paid.
- The price of rental service is determined on the platform by submitting it through the lessor. The customer's acceptance of the price and selection of service is considered an obligation from him to pay the amount upon completion of the service.

Indemnity:

Contract term and termination:

- You have the right to terminate the contract at any time by permanently deleting the platform installed on your smartphone, thus disabling your use of the platform and the service.
